

RESOLUTION NO. 2025 - 16

RESOLUTION AMENDING THE 2025 IRRIGATION SEASON

WHEREAS, on March 4, 2025, the Board adopted Resolution No. 2025-14 establishing the 2025 Irrigation Season; and

WHEREAS, since the Board adopted Resolution No. 2025-14, an additional 8 inches of precipitation has occurred within the Tuolumne River Watershed; and

WHEREAS, the April 1st snowpack percentage has increased by 18% since March 4, 2025; and

WHEREAS, Don Pedro reservoir elevation has increased by over 15 feet since March 4, 2025; and

WHEREAS, hydrological conditions in the Tuolumne River Watershed have improved overall since the Board adopted Resolution No. 2025-14 establishing the 2025 Irrigation Season.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Turlock Irrigation District do hereby amend Resolution No. 2025-14 to make amendments to the 2025 Irrigation Season as follows:

1. The amount of water available for each acre of irrigated land during the 2025 Irrigation Season shall be amended from 44 inches to 48 inches per acre.
2. Replenishment water will be available to in-Districts lands during the 2025 Irrigation Season for purchase at the 2025 Irrigation Tier 4 Rate of \$20 per acre foot.
3. Replenishment water availability to outside-of-the District lands will be considered by separate action of the Board.

Moved by Director Macedo, seconded by Director Alamo, that the foregoing resolution be adopted.

Recommended Action: Consider a resolution amending the 2025 Irrigation Season.




Background and Discussion: Don Pedro reservoir elevation is currently at 802.7, which is over 15 feet higher than what was presented at the March 4, 2025 Board meeting. Additionally, since the March 4 Board meeting, the Tuolumne River Watershed snowpack has increased by approximately 18% and more than 8 inches of observed precipitation in the Watershed has occurred.


All this being considered, coupled with low irrigation demand in the month of March, it is recommended that the District amend Resolution No. 2025-14 to increase the amount of available water from 44 inches to 48 inches per acre for the 2025 Irrigation Season. It is further recommended that replenishment water be made available to in-District growers for groundwater recharge purposes.
